Jasmin Pena, San Andreas High School, reported on the waitlist of referrals for San An, and the Golden Bell nominees, Dominique Uskert and Yaquelin Rodas.

Jack Haubold, Redwood High School, reported on the Leadership and Wellness activities, Prom plans, WASC visits, student career conversations, Junior conferences, and mask mandate transition.

#### 12. Trustee Considerations

#### A. Recognition of National Merit Scholarship Finalists

#### B. Announcement of Selection of New Redwood Principal

Dr. Taupier thanked the selection committee and coordinators for leading the process of finding a replacement for retiring Principal David Sondheim. Dr. Taupier introduced Mr. Barnaby Payne, who will begin his tenure on July 1st.
