1. Call Meeting to Order

A regular meeting of the Board of Trustees of the Tamalpais Union High School District (District) was called to order at 5:00 p.m. A quorum was declared present.

11. Student Trustee Reports

Jack Haubold, Redwood High School, attended the meeting in person and reported that the recent Anti-racist training seminar for students was meaningful and they are working on action steps. Homecoming activities and game are this weekend, and Leadership is planning service and fundraising projects for November.

Charlie Boyden, Tamiscal High School, reported on staff development and WASC report preparation, Yearbook planning, upcoming Halloween activities, a documentary about Tamiscal's Independent Study program being prepared for student outreach, and senior conferences with counselors.

Fiona Swan, Archie Williams High School, reported on spirit week and events planned for Halloween, homecoming, and students feeling positive and excited about campus activities.

Jasmin Pena, San Andreas High School, reported on Back to School Night and good parent/teacher communication, includign a welcoming room at San Andreas for Spanish speakers. Character awards are being planned, and COM counselors are visiting with students.

Lily Pashman, Tamalpais High School, couldn't attend because of a sporting event. Ms. Loebbaka reported for her on anti-racist workshops, sophomore parent night, Tam Unity Day, the Barrow Hall re-naming for Jewel Barrow scheduled on October 30, and the recent outdoor CTE production of A Midsummer Night's Dream.

12. Hold Public Hearing: TFT Sunshine Articles for TUHSD Negotiations

The meeting was adjourned at 6:20 to hold a public hearing. Erik Berkowitz and Melissa Boles, Co-Presidents of Tam Federation of Teachers (TFT), sunshined articles for negotiation with TUHSD. There was no public comment.

13. Hold Public Hearing: TUHSD Sunshine Articles for TFT Negotiations

Wes Cedros, Assistant Superintendent of Human Resources, sunshined articles for negotiation with TFT. There was no public comment.

14. Trustee Considerations

A. California COVID Vaccine Requirement Update

The meeting resumed at 6:25 pm with an update from Dr. Taupier on COVID vaccine requirements given the Governor's recent mandate which begins in the 2022-23 school year. She provided Marin County vaccine data and the board discussed issues such as accessibility, timing, exemptions, and masking, and how this will affect protocols in our District.

B. Discuss Substitute Teacher Pay and Coverage Increase

Dr. Taupier showed a comparison of sub pay rates for Marin County, which has much demand and a small pool of substitute teachers. To remain comparable to other Districts, a raise to \$190/day from \$150/day was recommended. M/S/C (Saavedra/Loebbaka), unanimously.

C. Approve Intradistrict Open Enrollment Capacity for 2022-2023

Dr. Taupier presented a report on the number of Open Enrollment requests for 2021-22, showing that less than 50 student transfers per school were requested. The demand has not changed significantly in the past ten years. M/S/C (Roenisch/Oppenheim), unanimously, to keep the cap at 50 students per school for the 2022-23 school year.

D. Update to Board Policy 6146-High School Graduation Requirements

Dr. Taupier suggested a revision to BP 6146 to streamline the process to waive Physical Education requirements for students who transfer into the District in their junior or senior year. The change will allow Principals to approve a waiver rather than requiring Board approval.

E. Review Governance Handbook and Governance Calendar

Ms. Harlander presented the governance calendar, and the board discussed appropriate adjustments to several items. For the Governance Handbook, the board discussed protocols for Topic 4, crisis/disaster and controversial topics. It was suggested to switch Topics 5 and 6, to have "Responding to Complaints..." follow Topic 4.
